## BUDGET

## Message from the Board of Directors Regarding the Proposed 2025-26 Annual Budget

At the Annual Meeting on June 8, the congregation will vote on the 2025-2026 budget. The Board hopes that the following narrative will help members in their consideration of the budget -- a budget that reflects the Board's vision for the future of the First Universalist Church. The Board's vision requires an investment in people: 61% of proposed expenditures is dedicated directly to personnel.

The budget reflects:

 $\cdot$  A full-time minister who is committed to a long-term future with us.

· Increased support of our amazing music staff.

 $\cdot$  Continuing support of our DRE who is slowly but surely growing an RE Program across age groups.

· Continued adherence to UUA Fair Compensation Guidelines for staff.

o Continuing staff salaries reflect these guidelines with a 2.5% increase (projected Social Security COLA).

The budget also shows:

 $\cdot$  A 7% increase in pledge income (many thanks to our Stewardship leaders).

 $\cdot$  A close to 100% increase in the rental income from 159 Pleasant Street (a direct result of the congregational vote in December to use Hackett Fund monies and of the hard work of Anne Perron and volunteers).

The Board did not create this budget lightly. Indeed, the 2025-2026 budget creates a potential gap of close to \$50,000 comparing projected income to projected expenses. This proposed budget continues a tradition of budgets with significant deficits. We propose to fill the gap this year by using funds from the checking account balance, certain monies within the Bob Thorpe Fund, and the Heritage Fund. Deficit budgets are not tenable over the long haul. However, the Board takes heart from the willingness of a minister and of eight new members to join us on our UU journey. We take heart from the flourishing of committee life, grassroots fundraising activities, and the rental possibilities of our building. We thank everyone for their gifts of time, talent, and treasure that sustain our beloved community

# COMMITTEE ANNUAL REPORTS

#### **Board of Directors Annual Report**

#### 2024/2025

The Board Report for the 2024-25 church year is indeed a Congregational Report as all of us -- the congregation -- were the agents of change this year. The following is an excerpt from our Minister Application that was submitted in January, responding to the question: *How did your previous ministry end?* 

"In August 2024, Reverend Terry Sweetser commenced what was projected to be a two-year ministry with us. We were excited about benefiting from Terry's extraordinary experience as a minister and as an administrator within the denomination. Terry was very much present: he led worship for his first eight Sundays and was on track to lead worship for 80% of the Sundays through the end of the year. Terry facilitated a retreat with Board and staff and an ongoing discussion with the Board of Peter Drucker's The Five Most Important Questions. He played a significant role in the relaunch of the Religious Exploration program under our new DRE. Then in mid-November, Terry became seriously ill and decided that he was unable to continue as our minister. There was no opportunity to say goodbye, to wrap up loose ends, or to plan for the future. The congregation is doing remarkably well - we are used to dealing with unanticipated change and uncertainty. Leadership has provided stability and continuity; our Worship Associates have created a full worship schedule with guest ministers and lay led services; congregation members have organized activities and celebrations. We have maintained momentum from our past 1 ½ years of renewal: RE has energy; we are looking to start the Welcoming Congregation Renewal program."

That momentum has continued with increased pace. Committee life has prospered as is clear from the reports that follow. Worthy of note: the Stewardship Campaign hit its mark; Adult RE's celebration of Esther Tucker within the context of the new Unitarian Universalist covenant; the rebirth of the Social Justice committee under the mentorship of our justice work consultant, Reverend Diane Fisher; the recent New Member Service which welcomed 8 new members. Our loyal cadre of guest ministers (Rev. Diane Fisher, Rev. Erica Hewitt, Rev. Mark Glovin) are happy to return to our pulpit and speak highly of our congregational vigor and vibe.

Reverend DC Fortune recognized that vigor and vibe and enthusiastically agreed to join us on our UU journey as a two-year contract minister with the goal of becoming the settled minister. Now the hard part begins.

- The Board has committed to growing our Music and RE programs and to compensating all staff fairly. The financial challenge is clear.
- Administrative support is still an issue. The plan outlined in last year's Annual Report was not a success. We hope that Reverend DC will help us create an effective system that works for the minister and the congregation.
- Breeze is still a work in process; there has been progress but there is still significant work to be done. Reviving the Newsletter, effective calendaring, and more effective means of communication depend on the full implementation of Breeze.
- The Building Use Taskforce is up and running. The first floor apartment at 159 Pleasant Street was renovated and is now producing a stable market rate rent. The Allied Field Church is a fine partner, but they are experiencing the fear and uncertainty that many immigrant groups currently experience. Are there more ways of taking advantage of our amazing building?
- We need more members.

Last year, concluding his Minister's Message, Patrick left us with the following: "I look forward to seeing you thrive and bloom in the coming years." He won't be disappointed.

#### **DENOMINATIONAL AFFAIRS REPORT 2025**

A focus of **Denominational Affairs** is encouraging members to form and experience a larger understanding of themselves as Unitarian Universalists by fostering UU connections beyond our own congregation.

One facet of this is creating our annual retreat at Ferry Beach with two other Maine congregations, the Allen



Avenue UU Church and the Norway UU Church. Another aspect is encouraging participation in UU workshops and conferences sponsored by other congregations or by the New England Region of the UUA and in attending our annual **UUA General Assembly** (G.A.).

The 2025 UUA General Assembly, with a theme of *Meet the Moment*, will be held this year in Baltimore, MD, with an option to participate online. Our two official lay delegates this June are Diane Chasse and Anne Kinney. Our soonto-be contract minister, the Rev. D.C. Fortune, will attend as well. We'll display our Auburn UU church banner during the 5-day conference.

At last year's General Assembly delegates took a monumental vote that replaces the existing 7 Principles and Six Sources language in our UUA bylaws with language that expresses six **Shared Values centered around Love.** The vote was the culmination of a multi-year process of discernment. It reflects UUism as a "Living Tradition" that continues to evolve as we grow and expand our awareness of systemic oppressions and expressions of our UU faith.

As Denominational Affair Representative I regularly communicate with the UUA Data Services Office to provide updates about changes in church leadership, staff, and membership. At the beginning of each year I work with our church leaders to complete our annual – and extensive – Certification of Membership with the UUA, a process required for us to have G.A. delegates. Along with this is helping the congregation understand the importance of paying our fair share to the UUA Annual Program



Fund, and including a line item in our budget to help with costs of workshops, trainings, and conferences.

The UUA and the New England Region (NER) have numerous tools and resources available for us to utilize as congregation. They can help us with guest ministers and worship materials, social justice ministries, religious exploration curricula, stewardship ideas, pastoral care trainings, board retreats, conflict engagement, leadership development, membership pamphlets, hymnals and music resources, and much, much more.

#### Endowment Committee Annual Report

#### 2024/2025

The current fund balances are as reported in Maureen's report to Ellen. The total of our endowments is about \$574,000.

In the last 10 years, the annual return has been 6.38%. That includes all fees (investment management – 0.83%; MCF fee – 0.85%. Total - 1.68%).

Grant budget is 4% of the rolling 12-quarter average balance as of 9/30. Any available funds not requested roll over into the next year's Available.

We are annually allowed to spend about 3.5% of the fund balance without a vote of the congregation. Earnings above 5.15% go into the principal, which can only be drawn down by a congregation vote.

#### **Financial Secretary's Report**

#### 2024/2025 Annual Meeting Report

#### Account Effective March 31, 2025

The Financial Secretary keeps the records of all funds of the church except for the Treasurer's checking account. The Financial Secretary is a member of the Finance Committee and Investment Committee. All funds coming into the church goes through the Treasurer. The Treasurer transfers any funds that are designated for a special purpose and reports these transfers to the Financial Secretary for record keeping.

Monies are invested in several different funds and at various institutions. These include a money market account at Maine Community Bank (MCB) formerly known as Mechanic Savings Bank, a CD at Dirigo Credit Union and a large amount of funds invested at the Maine Community Foundation. The Maine Community Foundation funds earned approximately \$33,655 over the past year. In addition, approximately \$14,640 have been withdrawn from the Building Endowment Fund at the Maine Community Foundation to support the annual budget. The attached spreadsheet shows the balance in each fund as of March 31, 2025. The various funds include the following:

General Fund - Unrestricted funds invested in MCB money market account

*Memorial Fund* – Established in 1959 with the stipulation that interest only be used as a fitting memorial to those for whom the memorial gifts were given. In 1972, the Board voted "to place all funds received from legacies, gifts and inheritances in the Memorial Fund with appropriate name of giver and only the income thereafter be spent". Funds are invested in MCB money market account and Maine Community Foundation.

*Stained Glass Window Fund* – Restricted funds invested in MCB money market account.

*Nancy Hill Fund* – Established by a bequest from Nancy Hill in 1913. She designated one half of the funds be invested and the earnings only be used for charity. The other half of the funds are invested and the earnings only can be used for the maintenance of the church edifice. The part for charitable use was invested in shares in the Northeast District UUA on March 31, 1968. Funds are invested in MCB money market account at Dirigo CD.

*Organ/Piano Maintenance Fund* – Established in 2003 from an anonymous donor. Restricted funds invested in MCB money market account.

*Music Fund* – Established in 1980 with an initial donation from Clyde and Thelma Thorpe. Funds are used to enhance the music program. Funds invested in MCB money market account and Maine Community Foundation.

*Social Justice Fund* – Established in 2016. Restricted funds invested in MCB money market account.

UU Theater Fund - Restricted funds invested in MCB money market account.

*CFAC Fund* – Unrestricted funds invested in MCB money market account. These funds are available to the general fund.

*Emery Youth Scholarship Fund* – Marion Bunney Emery Fund established for youth to attend Ferry Beach Youth Camp. Funds invested in MCB money market account. Combined with the Ferry Beach Account

*Ferry Beach Fund* – Restricted funds invested in MCB money market account. Now known as the Ferry Beach/Emery Youth Account

*Bob Thorpe Building Fund* – Established for building maintenance and emergencies. Funds invested in MCB money market. Funds from the closed Hackett Fund included in this account

*Bill Prescott Fund* – Restricted funds used for capital maintenance items. Funds invested in MCB money market account.

159 (Pleasant Street) Apartment Rental Fund – Security deposit being held on the apartment rent. Funds invested in MCB money market account.

*Prepaid Pledges* – This is a new fund set up to track pledge funds received in advance of the beginning of the new fiscal year. These funds will be recognized as income when the new fiscal year begins. Funds invested in MCB money market account.

*Hackett Fund* – Fund established when the church sold the parsonage on Park Avenue. John Hackett donated the funds to build the parsonage. When the parsonage was sold, the congregation voted to invest the money and make it available for future ministers to borrow at a low rate of interest to purchase a home. Funds are invested at Maine Community Foundation. This fund was dissolved in 2024 and the funds added to the Bib Thorpe Building Fund for the purpose of renovating 159 Pleasant St so the church could receive rental income from both apartments.

*Building Fund* – Established as a result of funds from several donors. Income can be used to support the church building. Funds invested at Maine Community Foundation.

*Heritage Fund* – Established with funds remaining from the Arlene Siekowski and several other bequests

#### **Religious Education/Exploration (Children) Annual Report**

#### 2024/2025

Religious Education/Exploration at Auburn UU has completed and planned the following since the beginning of the church year from 2024-2025:

- In the beginning of the church year I met weekly via phone call with Rev. Terry to discuss the RE Program.
- After Rev. Terry's departure, I have been having weekly phone meetings with David Das, President of the Board.
- We added a quiet play area in the back of the sanctuary for children during worship including soft toys, books, puzzles and coloring pages.
- Time For All Ages finally has a consistent style to it. There were originally some varying opinions on how it should be done (and if it should be done).
- RE Classes started up again since the pandemic on October 6th, 2024.
- It was decided to use the Soul Matters curriculum for the most part during this church year. We will likely continue with this in the next church year.
- RE Classes have been possible thanks to two volunteers in particular.
- We have had eight children/youth registered for RE Classes this year. The age ranges are from 5-13 years old. Although, in addition we do also have some children that are too young to become registered for classes just yet. Unfortunately, due to the short volume of volunteers, we were only able to focus on the younger curriculum this year but have a hopeful plan to offer classes for a wider age range next church year in the fall.
- We held a RE Family Game Night for all ages.
- As Religious Education Coordinator, I participated in a Trunk-or-Treat event held by Mr. Drew and His Animals Too. We had candy donated from the congregation. I decorated my car to the theme of "Spread Kindness Around Like Candy" and handed out RE flyers to those who asked for one. We won first place for the organizations/businesses that participated. Thus, we were able to have a free presentation by Mr. Drew at our church. There were a good amount of children and adults in attendance. A couple of children that don't usually come to church attended as well.
- I did research on other churches and their safety policies. I drafted a version that we could use. The Board voted it as acceptable to use. The document is titled: "Auburn UU Safety with Children and Youth Policy."
- We now have an RE Committee that has met at least once since forming.
- We've had background checks go through for current and potential RE volunteers.

- I met with Rev. Debbie Rogers Duval from the High Street Congregational (UCC) down the street from our church. We have plans to meet again once Rev. DC begins to see if we can have some sort of OWL and/or interfaith collaboration for children/youth. We also have one adult who might be interested in becoming trained and leading OWL classes for grades 7/9 and 10/12.
- Lastly, I plan to have Summer RE Classes this year that focus on a common project for all ages of children/youth to participate in. They will focus on the project(s) all summer and have a reveal event at the beginning of the church year.

I am so thankful to those who have stepped up to aid and help with Religious Education/Exploration this year in any capacity. I look forward to working together throughout another fruitful year!
