# President's Report:

- Robin Smutny Trust:
  - o Long time member Robin, who recently passed away, willed a generous trust to the church. Ellen O'Brien, Ned Claxton, and Greg Bianconi are working with Robin's lawyer on the details.
- On-boarding process for Reverend Patrick
  - Anne has been connecting Reverend Patrick via email to various church committees and groups.
- Updated Directory ready to be printed and distributed
- Vandalism in the Sanctuary:
  - o Music belonging to Phil was stolen.

- His 35<sup>th</sup> anniversary picture (Phil, Jodi and Pam) was taken from the organ bench and smashed.
- Meeting with DIC leadership on August 10
  - o Met with Greg, Patty, and Ben
  - o Positive meeting
    - Goal of reinforcing good relations
    - DIC sees the Church as the "host;" will engage with the Church as the "host."
  - o Board suggestion that both groups meet on a regular basis

# Open Session:

- Mary Kay
  - Need some clarity regarding Claudia's email address
  - o Fire doors have been propped open need to be closed
  - o Fire alarm going off Peter Floyd is being alerted with each alarm
    - Anne: Probably due to renovation activities (sanding) in office; Need to change who gets called.
- Levesque
  - Levesque did a walk through of the 1<sup>st</sup> floor apartment at 159
     Pleasant with City of Auburn Electrical Inspector in preparation for the change of use application
    - List of electrical upgrades and smoke and CO detector requirements

## Minister Search Update:

- We Have A Minister!
  - o Official start date on August 28; 1st Sunday will be September 10.
  - o Plan a series of messages to the congregation

o Can remove this standing agenda item

# 1st Floor Apartment at 159 Pleasant Street

- John suggested that the congregation expected a vote on the use of the apartment
  - o General Board consensus that there was no expectation of a vote
    - No change of purpose: ministerial use
    - Still not bringing in revenue
    - Vote would be required with any major renovation
      - Need for a plan and \$\$\$
- Anne and John will work on a communication to the congregation regarding the apartment (as part of the broader series of communications with Reverend Patrick's arrival)

#### **Email Issue**

- Discussion at DIC/Board meeting regarding a negative email sent to the Board from a member of the DIC leadership; negative comments directed at Anne.
  - o DIC aware of the email and who sent it; requested that the Board provide them with a copy of the email.
- Should Board provide the DIC with the email?
  - o Yes:
    - allow the DIC to address the issue internally
    - stop similar emails in the future
    - make the DIC aware of how some Board members have felt disrespected
    - create a policy regarding negative emails
    - help our relationship with the DIC
  - o No:
    - The DIC knows who sent the email; can work with that person directly
    - People need to be able to vent
    - Should the Board get in the habit of sharing emails; does the Board wish to be perceived as hanging people out to dry?
    - Previous consultation with UUA suggested that Board simply acknowledge negative emails and ask that the sender stop the practice
    - The importance of moving on; of taking advantage of all the current positive momentum

- Guest Comments:
  - Levesque: DIC can request the email directly from the person who sent it.
  - Mary Kay: need for consistency regarding nasty emails, with how to deal with all the negative stuff
    - A policy?
    - Good topic for a Committee on Ministry
  - Angela:
    - Email already several months old that ship has sailed.
    - As a congregant, she would like to be confident that she could send an email to the Board without it being shared.
- Decision: Board will contact the DIC -- ask them to go directly to the person (if they so wish); the Board will not share the email due to privacy considerations.

# Security Camera Policy:

- Background information
  - o Anne shared an image from security camera feed
    - Showed member of DIC entering code on lobby door keypad while a guest looked on.
    - Concern that guest now has entry code
  - o People are in church when and where they should not be
    - Cigarette butts found in church
    - Vandalism of Phil's space
    - Powder on lobby floor
  - o Outdoor cameras have helped in eliminating waste, garbage, and drug paraphernalia.
- Plan to install 4 more cameras
  - To cover all exits
  - o To have greater interior coverage
- Concern about security of Sanctuary
  - o Use the current camera set up to monitor Sanctuary 24/7?
  - o Expand security camera system to the Sanctuary?
  - Lock doors to the Sanctuary: Phil and Pam thought that this was in the works pre-COVID.
    - Key access issues rear their ugly head
  - o Importance of Sanctuary as a sacred space; expectation of privacy.
- Guest Comments:

- Esther: why not install an alarm system in Sanctuary? Camera information already too late; an alarm could prevent vandalism and theft.
- Levesque: vandalism totally unacceptable; need to address it as forcefully as possible
- o Angela:
  - Use the separate security system; keep it simple.
  - Use of existing broadcast camera system in Sanctuary raises logistical and trust issues.
- Board Action Plan:
  - o Created Camera Policy Task Force: Anne, Claire, John, Levesque
  - o Policy to consider:
    - Privacy concerns
    - Who has access
    - Who can request to see footage
    - Who has the need to know
    - When to share with law enforcement
  - o Draft Policy to be presented at September 6, 2023 Board Meeting
- Guest Comments:
  - o Angela: advisable to create a policy template so that there are agreed upon expectations around the structure of a policy; would provide structure and clarity to those tasked with creating policies.

### **Town Hall Recap**

- General appreciation of how well Town Halls are working
  - o Good attendance, both in person and online
  - o Constructive and broad participation by those in attendance
- Agreement that virtual element of Town Hall needs tweaking in order to work more smoothly; to allow for greater participation
  - Board member to monitor chat during Town Hall
- Next Town Hall
  - October 1 to discuss 2023-2024 budget in preparation for October 15 Congregational Meeting
