• Newsletter: who to take over editorial responsibility?

To-Do List: Prioritize

- 1. Discernment process
- 2. Create a task force to find alternative to Robert's Rules. Angela Foss to coordinate the task force.

2a. Rebooting Council of Committees. Scheduling a meeting. How to recruit without a Nominating Committee? How to craft and put out the call for volunteers?

- 3. Update Church Directory
- 4. PSDIC parameters: how to manage a low-barrier drop-in center? How do a low-barrier center and a low-barrier church interact? Health and safety standards.
- 5. Religious Exploration: next steps? What does RE look like across the UUA? Rev. Jodi to investigate RE models.
- 6. Zoom participation at Board meetings. Need to craft a policy bearing in mind the destructive impact of Zoom participation at Spring/Summer 2022 Board meetings.

Discernment Process around the PSDIC:

An extended discussion. Broached the possibility/desirability of an outside facilitator. Rev. Jodi to connect with facilitator.

Sketched out a three part process:

- Frequently Asked Questions: create a list of questions and answers; distribute it as a handout and online.
- Truth Telling: facilitated sessions where people may name their experience.
- Discernment: specific discussion of how to make co-existence possible. Discrete issues and topics.

Guest Comments:

• Levesque:

- expressed their concern about PSDIC guests smoking (weed and tobacco) on church grounds; church goers should not be asked to walk through/by the smoke; it creates a bad impression of the church.
- Status of PSDIC 501(c)(3) plans?
- All conversation between Board and PSDIC co-chairs should be in public at meetings of the Board.
